NNSDO 2010: 2 San Diego November 2009 Program: The Joint Commission National Patient Safety Goals and Universal Protocol, 2010! *Featuring Susan Hill* 

Our November 6th Program was held at California Hospital and opened with a dynamic tabletop activity led by OHE's own VP of Programs, Dwanette Judkins.

In an effort to maximize exchange of ideas and networking, Dwanette "assigned" seating so that attendees from the same hospital were separated.

The activity used case scenarios and gave participants an opportunity to share their successes and challenges in meeting the 2009 NPSG compliance requirements.

The program key speaker, Susan Hill, led a 3-hour practical discussion and description of the National Patient Safety Goals and Universal Protocol changes for 2010, and their re-write intent and process.

Susan's knowledge of hospital processes as well as her extensive experience as an RN helped to bring the "down and dirty" of the changes in the current accreditation standards, EP's and survey changes. Susan engaged the group in lively discussions around what the impact would be for agencies seeking accreditation.


